ठाणे महापालिकेने 'टीएमटी'च्या तोंडाला पाने पुसली

४६० कोटींऐवजी अवघ्या १५० कोटींवर बोळवण

हात. शासनाकडून वस्तू व सेवा कर अनुदानाची रक्कम नियमितपणे दिली जात होती. त्यामुळे डिसेंबर २०२१ अखेरपर्यंत यातून महापालिकेस ६८० कोटी, १३ लाख प्राप्त झाले आहेत. त्यामुळे उर्वरित रक्कम पुढील काळात व्यवस्थित मिळू शकणार आहे. परंतु, मुद्रांक शुल्क अधिभारार्पाटी अपेक्षित धरण्यात आलेल्या २३० कोटींच्या अनुदानापैकी डिसेंबर अखेर ३२.८२ कोटी मिळाल्याने मुद्रांक शुल्कापोटी मिळणे अनुदान ५० कोटीपर्यंतच पोहोचणार आहे. तर जकात आणि 'एलबीटी'च्या थकबाकीतून १२ कोटी मिळाले आहेत. त्यामुळे मुद्रांक शुल्कापोटी अपेक्षित उत्पन्नामध्ये आलेल्या तूटीमुळे या माध्यमातून मिळणाऱ्या उत्पन्नाला ग्रहण लागले आहे. अपेक्षित धरण्यात आलेल्या ११५२ कोटी, ७० लाखांपैकी डिसेंबर २०२१ अखेरपर्यंत ७२५ कोटी मिळाले असून, पुढील काळात

उत्पन्न मिळू शकणार असल्याने यामध्ये १८० कोटींची मोठी तूट आल्याने ठाणे महानगरपालिकेच्या उत्पन्नाला घरघर लागली आहे.

पाणीपट्टी वसुलीचे मोठे आव्हान

ठाणे महापालिकेच्या पाणी पुरवठा विभागाकडून दरवर्षी १५० कोटीहून अधिक रकमेची पाणीपट्टी वसुली केली जाते. २०२१-२२ या आर्थिक वर्षामध्ये २०० कोटीचे उत्पन्न अपेक्षित धरण्यात आले होते. परंतु डिसेंबरपर्यंत जेमतेम ५३ कोटींचेच उत्पन्न मिळाल्यामुळे सुधारित अंदाजपत्रकात ही रक्कम १५८ कोटी करण्यात आली. तेव्हा, पुढील दोन महिन्यात १०० कोटीहून अधिक रक्कम वसूल करण्याचे मोठे आव्हान पालिकेसमोर असणार आहे.
