It's more than just fashion for Naomi Osaka in Paris

It's more than just a fashion show for Naomi Osaka at the French Open. The four-time Grand Slam champion has advanced to the fourth round at Roland Garros for the first time in her career.

Osaka beat 18-year-old American opponent Iva Jovic 7-6 (5), 6-7 (3), 6-4 over nearly three hours on Saturday, in her 100th Grand Slam match.

Once again, Osaka wore a metallic gold bomber jacket over her sequined gold playing dress during her walk-out. But this time her outfit was offset by a tanish-gold colored train that stretched all the way down to the red clay on Court Suzanne-Lenglen.

For her opening match, Osaka walked in a ceremonial black skirt and sleeveless beaded bodice before revealing her gold dress, which she said reminded her of the Eiffel Tower sparkling at night. Then she had on the bomber

jacket and an ivory-colored train for her second match.

"It's a surprise every time," Osaka said of her fashion choices. For the seventh straight day of the tournament, it was hot and humid, with the temperature forecast to rise to 34 degrees Celsius (93 Fahrenheit). The heat is

expected to break for Sunday and the second week.

Midway through Osaka's victory, a spectator was carried out of the stadium on a stretcher due to an apparent illness.

Brazilian teenager Joao Fonseca scripted a monumental upset at the French Open on Friday night, eliminating 24-time major champion Novak Djokovic in a five-set thriller to ensure a new men's champion will be crowned.

The 19-year-old Fonseca fought back to defeat Djokovic 4-6, 4-6, 6-3, 7-5, 7-5 in the third round. The stunning result followed Thursday's massive upset over top seed Jannik Sinner lost to Juan Manuel Cerundolo. With Daniil Medvedev, Marin Cilic, and Stan Wawrinka already eliminated, a new champion is guaranteed to lift the Coupe des Mousquetaires trophy on June 7.

Liverpool fired manager Arne Slot on Saturday following a troubled second season in charge, just a year after he won the Premier League title. Fenway Sports Group, the club's American ownership, said it made a "difficult" decision after Liverpool finished fifth and trophy-less in a disappointing defense.

"We have collectively come to the conclusion that change is necessary in order for the club to keep moving forward," the ownership said in a statement. "Again, it must be stressed that this is not a decision which has been reached lightly; anything but."

Slot replaced club icon Jurgen Klopp in the summer of 2024 and led Liverpool to a record-tying 20th English league title. Liverpool spent an unprecedented \$870 million to strengthen the squad for his second season but most of the expensive signings, including Florian Wirtz, Jeremie Primpong and injury-hit striker Alexander Isak, underwhelmed.

Satwik-Chirag enter Singapore Open final

The Indian pair upsets world champions in doubles semifinal

India's top men's doubles combination of Satwiksairaj Rankireddy and Chirag Shetty knocked off reigning world champions Kim Won Ho and Seung Ja of Korea in straight games to reach the final of the Singapore Open Super 500 badminton tournament on Saturday.

The fourth-seeded Indian pair registered their first victory over the Korean duo in three meetings, winning the semifinal clash 21-18, 21-18 in minutes to reach their second World Tour final of the year. In the semifinal on Satwik and Chirag fought back after conceding early leads in both games against the Koreans. The Indian combination trailed 8-13 and then 10-17 in the opening game but held their nerves under pressure to clinch the game.

"When we were down, we kept calm and backed ourselves because we knew if we stuck to our plan, they would crack at some point," Chirag
